The use of the Daedo EBP requires every competitor to wear a special foot protector which enables automatic electronic scoring. This foot protector has to be bought by the competitor himself and will not be provided for free by the organizer. Therefore all federations participating at the Miami Taekwondo Federation Daedo True Score International Championship are required to order the appropriate number of foot protectors for their team before September 25th 2010. This device (THE E-HUGO) has been licensed by WTF and the MTF will be utilizing this system.

International Teams from: Puerto Rico-Dominican Rep-Aruba-Mexico-Suriname-Curacao and France are coming to this event. This event is a single elimination sparring event. Open To All.

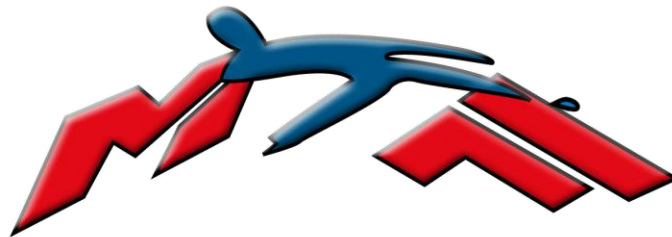
